

Christian Filipina Partner Program Terms of Service Agreement (“Agreement”)

Please carefully review this Agreement before subscribing to the Christian Filipina Partner Program. By accepting these terms following the outlined procedures, you indicate your intention to abide by this Agreement.

1. Definitions

- 1.1. **“Partner”**: The individual or legal entity applying for and accepted into the Program.
- 1.2. **“Referral”**: A unique, new individual who is not a previous or existing member of Christian Filipina or Filipino Visa, who arrives at the TLI Sites via a Partner Link, and completes a registration.
- 1.3. **“Qualifying Sale”**: A transaction where a Referral pays for a service in full or enters a valid payment plan within sixty (60) days of their initial registration.
- 1.4. **“Partner Link”**: The unique tracking URL or HTML code provided by TLI to the Partner to connect their site to TLI Sites.
- 1.5. **“TLI Sites”**: The official websites owned and operated by Together Light Incorporated, specifically including ChristianFilipina.com and FilipinoVisa.com.
- 1.6. **“Commission”**: The specific dollar amount owed to a Partner for a Qualifying Sale as outlined in the payout structure.
2. **Parties**: The Christian Filipina Partner Program is a service agreement between Together Light Incorporated (“TLI”) and you. Together Light Incorporated is a Delaware corporation domiciled in the United States of America.
3. **Agreement**: By participating in the Christian Filipina Partner Program, you agree to abide by the terms and conditions outlined in this Agreement.
4. **Eligibility**:

- 4.1. To be eligible for the Christian Filipina Partner Program, you must be at least 18 years old.
- 4.2. TLI reserves the right to refuse your application to link to TLI Sites if your site is deemed unsuitable, including, but not limited to, explicit content, discriminatory material, defamation, illegal activities, or poor quality design.
- 4.3. Upon acceptance, your application becomes part of this Agreement.

5. Partner Responsibilities

- 5.1. Promotion: Partners agree to actively promote Christian Filipinas using approved marketing materials provided by the program.
- 5.2. Ethical Conduct: Partners must ethically conduct themselves and refrain from engaging in any form of deceptive or misleading practices.
- 5.3. Tax Compliance:
 - 5.3.1. US citizen partners must submit tax forms as per the Internal Revenue Service (IRS) regulations.
 - 5.3.2. Non-US citizen partners must submit a non-tax declaration confirming their non-US resident status for tax purposes.
 - 5.3.3. All partners must provide accurate, up-to-date tax information. Failure to comply may result in suspension or termination of the partnership.
 - 5.3.4. Partners must promptly notify the company of any changes in tax status.

6. Partner Link:

- 6.1. Upon acceptance, Christian Filipina provides a Link containing HTML code to connect your site to Christian Filipina Sites, allowing you to promote Christian Filipina and Filipino Visa Services.
- 6.2. You may display the Link on your site to identify it as a Partner and establish a link to Christian Filipina and Filipino Visa Sites.
- 6.3. You agree to cooperate with Christian Filipina and Filipino Visa in maintaining the Link, displaying provided graphic images, and following Christian Filipina and Filipino Visa instructions regarding Link placement.
- 6.4. Links may be modified or extended during the Agreement term.

- 6.5. Christian Filipina reserves the right to review and audit your website and advertising practices occasionally to ensure continued compliance with this Agreement.

7. Commissions and Bonus Structure:

- 7.1. Overall Earnings Structure: Partners shall receive a commission for each eligible sale generated through their unique partner link. To qualify for a payout, the referral's initial payment must occur within **60 days of their original registration date**. This 60-day window applies to all services, including Christian Filipina (CF) and Filipino Visa (FV).
- 7.2. Christian Filipina Earnings Guidelines: Partners promoting Christian Filipina shall receive a commission based on the following payout structure for first-time paid registrations within 60 days of referral signup:
 - 7.2.1. \$150 for basic membership levels (up to \$500)
 - 7.2.2. \$300 for premium membership levels (exceeding \$500)
 - 7.2.3. Additionally, at the discretion of the Company, an additional quarterly bonus may be paid based on the number of legitimate, qualified male and female leads signing up and engaging meaningfully, even if the leads have not paid.
- 7.3. Visa Service Earnings Structure: Partners promoting the Filipino Visa service shall be entitled to a payout ranging from \$100 to \$500 for any client who pays in full or opts for a payment plan. The Visa Product Partner Program Commissions are as follows:
 - 7.3.1. If a referral pays \$97 - \$1,000 within the first 60 days from registration, the marketing partner shall receive a \$100 commission.
 - 7.3.2. If a referral pays \$1,001 and above within the first 60 days from registration, the marketing partner shall receive a \$500 commission.
- 7.4. Bonus Structure: Partners are eligible for a 10% bonus on tier-2 marketing partner commissions.
 - 7.4.1. Upon successfully referring another marketing partner, the referring partner shall receive an additional bonus equivalent to 10% of the earnings generated by the referred partner.
- 7.5. Chargebacks and Refunds: In the event of a chargeback or refund on a referral's payment, where an incentive has already been disbursed, the

corresponding commission of the marketing partner shall be deducted from subsequent payouts.

7.6. Payment Schedule:

- 7.6.1. Commissions shall be paid monthly, provided the partner has reached the minimum payout threshold of \$100.
- 7.6.2. All payments shall be processed through Wise or Bill.com unless alternative arrangements have been mutually agreed upon. Partners must submit any necessary tax forms to receive payment.

8. Prohibited Activities:

- 8.1. **Fraudulent Activity:** Partners must not engage in any fraudulent activity, including but not limited to click fraud, cookie stuffing, or other deceptive practices.
- 8.2. **Inappropriate Content:** Partners must not promote Christian Filipina through content that is offensive, illegal, or violates the rights of others.
- 8.3. **Infringement of Intellectual Property:**
 - 8.3.1. Partners are strictly prohibited from using any brand keywords, trademarks, or variations associated with Christian Filipina in PPC keyword bidding or by misrepresentation.
 - 8.3.2. Prohibited keywords include but are not limited to 'Christian Filipina' or any other distinctive terms identifying the platform.
 - 8.3.3. Additionally, the use of keywords related to Filipino Visa, such as 'Filipino Visa' or any variations, is strictly forbidden. This prohibition also applies to all forms of usage, including usernames, profile names, domain names, or content making it appear you are us.

9. Termination: Christian Filipina reserves the right to terminate a partner's participation in the program at any time for violating the terms outlined in this Agreement, or for any reason. We reserve the right to terminate any partner account at our discretion.

10. Modifications: Christian Filipina reserves the right to modify the terms of the partner program Agreement at any time. Partners will be notified of any changes by email.

11. Confidentiality: Partners agree to keep confidential any proprietary information Christian Filipina provides, including commission rates and marketing strategies.

12. Content Usage Rights:

- 12.1. **Grant of Rights:** By participating in the Christian Filipina Partner Program, you grant Christian Filipina a non-exclusive, royalty-free, perpetual worldwide license to use, reproduce, distribute, and display any content created by you to promote Christian Filipina, including but not limited to text, images, and videos.
- 12.2. **Social Media and Promotions:** Christian Filipina reserves the right to use the content you create about us for promotional purposes, including sharing on our official social media channels and other marketing materials.
- 12.3. **Attribution:** Christian Filipina agrees to provide proper moral attribution whenever possible and convenient when using the content created by partners.
- 12.4. **Limitations on publishing pricing and membership level details:** You are not permitted to publish current or past pricing information for any of Christian Filipina or Filipino Visa services, or details of the benefits of the various service levels we offer.
- 12.5. You may use TLI trademarks, logos, business names, and other creative materials licensed by us to you only in compliance with the terms of this Agreement, and only as long as we allow you to be a member of this program.

13. Dispute Resolution:

- 13.1. In the event of a dispute arising related to the terms of this Agreement, the dispute shall be resolved by binding virtual arbitration.
- 13.2. The laws of New Hampshire, United States of America shall govern the arbitration.
- 13.3. The arbitrator shall be mutually appointed by the Parties, and paid for by the disputing Party.
- 13.4. If the Parties cannot agree on an arbitrator, an arbitrator shall be chosen at random from <https://www.nhmediators.org/>.

- 13.5. The rules of arbitration shall be the Non-Administered Arbitration Rules listed under the CPR's website as the most current at the time of the dispute.
- 13.6. Any ambiguity between the arbitration rules and this Agreement shall be resolved in favor of this Agreement.
- 13.7. The arbitration shall be conducted in English.

14. Limitation on liability:

- 14.1. TLI is not and shall not be liable to you in contract or tort, related to this Agreement.
- 14.2. You shall indemnify and hold TLI harmless from all claims made by third parties due to your negligence or participation in the program, including but not limited to intellectual property and tort claims.
- 14.3. In no event shall TLI's total liability exceed the Bonus or Commission owed to you under [clause 6](#) of this Agreement.

15. Relationship: This Agreement does not create an employer-employee or any agency relationship between the parties. Any action or inaction on the part of the partner is not binding on TLI.

16. Governing Law and Jurisdiction:

- 16.1. The courts of New Hampshire (United States) shall have exclusive jurisdiction over any dispute arising from this Agreement.
